- ❑ Should be a president/CEO in a company; a corporate supplier diversity manager/director; or a decision-maker in a major corporation.
- ❑ Nominees’ name, present position, place of employment, address, daytime number, fax number, years in business or length of employment, and size of organization.
- ❑ Must submit a biographical profile in a word document, which is no longer than 600 words
- ❑ May be self-nominated or nominated by another person.
- ❑ Must provide two *different* professional color photographs. (*Photographs will be used for video production and editorial profile for the awards presentation*)
- ❑ If selected, *must* be able to travel to Washington, DC for the award presentation
